The Bellevue Community School District is always working to provide our students with the best possible educational opportunities in all areas, including academic areas and beyond. Recent legislation at the state level has prompted the BCSD to review, analyze, and evaluate various curricular materials utilized by our staff and made available to our students.

Specifically, new legislation specifies that all materials should be age-appropriate for specific students and grade levels by no later than January 1, 2024. The state defines "age-appropriate" to mean topics, messages, and teaching methods suitable to particular ages or age groups of children and adolescents based on developing cognitive, emotional, and behavioral capacities typical for the age or group. The Bellevue CSD authentically believes the materials we provide our students are age-appropriate at the different levels and meet these requirements when they are added to our district libraries or classrooms. Yet, we have taken note of this legislation and are investigating some potential changes to ensure we are meeting the state's legal requirements.

As a result, the district will continue to evaluate our materials in the libraries, along with an evaluation of classroom materials. Decisions will be based upon information from the district's legal counsel, input from the lowa Department of Education, and collaboration with our district administration and teacher representatives.
