Legislative Action - Vouchers

As many of our stakeholders, and citizens in our state are aware, the Iowa Legislature recently approved public tax dollars to be utilized by non-public schools across the state in a phased program. While there was significant opposition

WHAT WILL THE BALLOT SAY? On March 7, 2023, a date pre-determined by state law, Bellevue Community School District will hold a special election. Sixty-percent of voters must approve the question for the bond to pass. Shall the Board of Directors of the Bellevue Community School District in the County of Jackson, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$13,100,000 to provide funds to build, furnish, and equip a new elementary building and improve the site?

Vote early in person at the Jackson County Courthouse Monday through Friday from 8:30 a.m. through 4:30 p.m. February 15 through March 6.

ABSENTEE

Request an absentee ballot from the Jackson County auditor by February 20 (15 days prior to the election). Ballots must be received to the auditor by 8 p.m. on election day



presented in the days leading up to the votes to both the House and Senate from many people across the state (including several from Bellevue), this was passed hurriedly in both branches. A concern expressed by many is the additional funding that will be granted to school systems that are not required to allow all students in school, meet all standards and requirements of public schools, and other aspects. Finally, many believe the excess of funds to non-public schools will impact overall school funding in the future, along with funding to other areas of our society.

Ultimately, I don't know the impact overall on education in our state in the short- or long-term, I do know that the Bellevue CSD will continue to provide outstanding programs to our students and work to continuously improve them in the future as well. We will continue to offer programs that engage our students in their learning and prepare them for their future. 
